## VENUE AND SEATING CAPACITY

Mountain Ridge Wines offer a purpose designed marquee to host your wedding or special celebration. The clear walled marquee allows your guests to enjoy stunning Mountain Ridge views: picturesque South Coast country side with macadamia trees, vines, manicured lawns and Berry Mountain Range as a back drop.

Mountain Ridge Wines can cater for weddings with guests of up to 100 (sit down) or up to 150 (cocktail).

Venue hire of \$5,500 is based on six hours plus one hour for your ceremony. The hire includes the use of our lawns for your ceremony. You are welcome to erect your own arbour. You may access the venue to set up prior to your function, typically the day prior to your booked event date.

Mountain Ridge Wedding Marquee features clear walls to allow for perfect views, timber floors, rectangular tables (that may be arranged to suit your seating plan), padded white folding chairs, lighting, bar area as well as adjoining dance floor. Different chairs and tables, table linen and additional decorative lighting are all available as optional extras.

## CHILDREN AND SPECIAL DIETARY NEEDS

Mountain Ridge Wines welcomes children and a children's menu is available for those aged 12 and under.

A children's main course (please refer to our current menu) served with chips or salad, followed by ice-cream for dessert is \$30 per child. Alternatively, you are welcome to include children in full adult menu, in which case full price applies.

Please advise at the time of the booking if you require high chairs or space for prams etc.

Any guests with special dietary requirements can be catered for.

Our chefs will be happy to accommodate any special dietary meal options your guests require. These may include gluten free or vegetarian meals or tailored meals for guests with allergies. Please discuss any special dietary requirements with our team members when booking your function.



## TERMS & CONDITIONS (page 1)

### FUNCTION TIMES:

Our evening wedding package is based on six hours plus one hour for your ceremony. Guests may arrive from 3.30pm with the ceremony commencing at 4pm. All entertainment must finish by 10.30pm, and all guests must leave by 11pm. Bar service will cease at 10:30pm and cannot be extended. Function extensions are only possible by special arrangement (to organise the ceremony to start earlier). Fees and conditions apply.

### MINIMUM NUMBERS:

A minimum guest number of 80 apply for all evening events on a Friday, Saturday, Sunday or a public holiday. Minimum guest numbers may apply during other times. Please note maximum number for guests for a sit down event is 120 and for cocktails is 150.

### GUARANTEED NUMBERS:

Final guest numbers are required 14 days prior to your function. Final function charges are based on guaranteed numbers. Additional charges will apply should the actual number of guests on the day exceed the confirmed number of guests.

### DEPOSIT AND PAYMENT TERMS:

A deposit of \$2,000 is due to secure your booking date and must be accompanied by a signed copy of our booking agreement. Confirmation of final numbers and final payment is due 14 days prior to your function. In the unfortunate event of cancellation - more than 14 days before booked date - your deposit will be refunded minus \$500 cancellation fee. Refund will be provided only if Mountain Ridge Wines is able to secure another function on the same date. You will be responsible for the full cost of the function should you cancel within 14 days of the function date.



## TERMS & CONDITIONS (page 2)

### WEDDING CAKES:

You are more than welcome to provide your own wedding cake. Mountain Ridge Wines will happily portion the cake for the guests and display it on tables for guests to help themselves. There is no additional charge for this. If the wedding cake is to be served as a substitute for dessert, a cakeage fee of \$3 per person applies.

### BANDS / ENTERTAINMENT:

At Mountain Ridge Wines we encourage you to book your own DJ or entertainment. Any entertainment is subject to Mountain Ridge Wines approval.

### ACCESSIBILITY:

Please advise us if your guests have particular access requirements. Mountain Ridge Wines has wheelchair accessible amenities available inside the main restaurant building.

### BEVERAGE SERVICE:

At the time of the booking you will decide the amount of prepaid drinks (tab) based on estimated amount of drinks per guest. Beverage service typically commences with pre-dinner drinks following the ceremony. Mountain Ridge Wines is a licenced premises and actively practices responsible service of alcohol. Any guest under the age of 18 will NOT be permitted to consume alcoholic beverages. Appropriate proof of age may be requested by staff. No BYO beverages are permitted on es and any guest failing to comply will be asked to leave. Mountain Ridge Wines supports responsible service of alcohol. It is illegal to serve alcohol to: intoxicated patrons, disorderly patrons, patrons under the age of 18.



## TERMS & CONDITIONS (page 3)

### SMOKING:

Mountain Ridge Wines is a non-smoking venue. No smoking is allowed inside any building, marquee or toilets. Ash trays and an area for smoking is provided outside in marked location.

### DECORATIONS AND CANDLES:

All decorations and structures must be approved by Mountain Ridge Wines. All decorations brought to Mountain Ridge Wines will be the sole responsibility of the person supplying them and are doing so at their own risk. Whilst Mountain Ridge Wines staff will take all care, no responsibility for any damage is accepted. No confetti, rice or glitter is allowed - however, rose petals are acceptable. Mountain Ridge Wines reserves the right to alter the decor or fixtures without the notice to the client. No candles with naked flame are allowed.

### RESPONSIBILITY OF GUESTS AND CONDUCT:

The person responsible for the booking is the person who has signed the booking agreement. The person will be liable for the cost of any damage incurred at the venue or in the grounds of the venue during the function. Mountain Ridge Wines reserves the right to evict any guest from the premises should we believe they are behaving in an unreasonable, dangerous or unbecoming manner. Any guest who is endangering the health, safety or wellbeing of any staff member or guest, will be immediately evicted from the premises REGARDLESS OF THE ROLE they may have at the function. No noxious, dangerous or illegal substances are allowed on the premises. Mountain Ridge Wines reserves the right to immediately notify the authorities in such an event. It is the responsibility of the hirer to take all reasonable precaution for the safety of their suppliers, guests and / or invitees.

### PARKING AND TRANSPORTATION:

Free parking is available at Mountain Ridge Wines for approximately 50 cars. We strongly recommend looking into hiring a bus or a shuttle service for guest transportation. No reliable taxi services are available in the area. Mountain Ridge Wines offers no transportation services. All vehicles should be removed from the property by the end of the function, should this at all be possible. Any vehicles remaining on the property are at their owner's risk. No responsibility for damage is admitted by Mountain Ridge Wines.

### LOSS OR DAMAGE:

The hirer, the person signing the booking agreement, is solely responsible for any damage sustained to the venue and/or grounds during the function in a legal or financial respect. Mountain Ridge Staff take all care but accept no responsibility for loss or damage of items before, during or after the function. Mountain Ridge Wines reserves the right to cancel without notice any function in the event of an emergency or unforeseeable circumstances which may deem this action necessary to maintain the health and safety of guests and/or staff.

### WINERY OPERATIONS:

Please note that Mountain Ridge Wines is a working farm and operating winery. Throughout different stages of the year Mountain Ridge Wines reserves the right to make any changes to the scenery and surroundings of the property. This may include netting or pruning of the vines. Restrictions may also apply to use of special sections of the property at certain times of the year - such as the macadamia tree plantation or vines. All children must be supervised at all times by a responsible adult / guardian. All guests must remain in areas designated for the function.

# TERMS & CONDITIONS (page 4)

## FULL PAYMENT:

Full payment for your function package is required 14 days prior to the event.

## SECURITY BOND:

A \$1000 bond is required to secure against any damage to Mountain Ridge property. This will be returned to you within 3 days of your event assuming no damage has occurred. If any damage has been sustained, you will be notified of the damage and the cost of repairs.

## COLLECTION OF BELONGINGS:

Any belongings brought onto the property, including flowers, centre pieces and decorations will be packed up and must be collected within 3 days.

## DECORATIONS:

We are happy for you to add your own personal touches and encourage you to decorate accordingly. We do not permit the use of tacks, nails, two way tape or blu tac.

## CLEANING COST:

A cleaning cost may be charged if the venue or grounds are left excessively untidy or damaged. This includes damage to trees and gardens.

## LIABILITY:



The person signing the booking agreement takes full responsibility for control and conduct of their guests, suppliers or invitees, and for all activities undertaken by them whilst on Mountain Ridge Wines premises.

## FUNCTION AGREEMENT:

The hirer agrees to pay Mountain Ridge Wines the amount of any damages which may occur to the building, furniture, fittings, equipment or grounds as a result of the hiring or conduct of guests as outlined above. Mountain Ridge Wines may at its absolute discretion terminate any hiring should the premises be used for any other purpose than stated in the booking agreement, or if any function becomes disorderly, or any disturbance, nuisance or undesirable activity is allowed to occur. In the event of such termination, all fees and charges will be forfeited to Mountain Ridge Wines and all persons attending the function will be required to vacate the premises immediately.
